CARBON REDUCTION

Haag-Streit UK is part of the Metall Zug Group and its carbon reduction goals are aligned with the Group goals.

- ❷ By 2030 we have set a target to reduce Scope 1 & 2 CO2 emissions by 25%.
- By 2050, we have set a target to have net zero Scope 1 & 2 emissions.
- We will continuously reduce Scope 3 emissions of our products.

To continue our progress to achieving net zero, we have defined the following carbon reduction strategies:

- Use of on-site renewable energy generation where possible & procurement of 100% renewable electricity
- Replace further CO2 inefficient technologies with electrified or more energy efficient alternatives
- The electrification of our service fleet
- Engage in active analysis & implementation of circular economy projects to reduce the Scope 3 footprint of our products

- Evaluate all of our purchased products, with specific plans for more efficient use, such as reducing single use plastic, switching from disposable to reusable equipment and reducing the use of paper.
- Move to agile working that will result in reduction of company business travel & commuting.
- To utilise a carbon reporting tool to accurately record our carbon emissions.

In order to support our net zero goals, and in line with our 2030 targets to reduce CO2 emissions by 25%, we will be engaging with our supply chain and requiring suppliers to report their carbon footprint data to us, to improve the accuracy of carbon measurement and support our net zero goal.

- Supplying spare parts so that the longevity of a product is extended to reduce the need for more regular replacements

SUSTAINABILITY & ENVIRONMENT

Haag-Streit UK is committed to actions that preserve and restore the environment, including waste and emissions, saving energy, recycling materials and conserving resources. We aim to reduce the impact of our actions on the environment within the necessary constraints to produce safe and reliable products.

We are determined to minimise our direct impact on the environment by continually working towards improving our environmental performance and integrating recognised best practice into all operations, while complying with all relevant statutory requirements.

In order to reduce packaging waste, we have introduced a system of returnable packaging together with a supplier from Germany. In addition, we use a distillery plant for solvents at our Köniz manufacturing site, which has enabled us to reduce the consumption of solvents by around 70%.

We operate an effective manufacturing recycling process to ensure that the optimum amount of raw and waste materials is reused or recycled. While this has the most impact on our Group recycling programme, we have launched a recycling and food waste initiative for all staff to improve material separation in offices and break rooms to reduce further the

amount of waste going to landfill.

Haag-Streit UK is committed to sustainability performance as an integral, strategic issue that shapes the future of our business, and supports our reputation as a respected medical device manufacturer. We have a measurable sustainability framework for key areas of our business, and we believe that engaging with stakeholders on sustainability brings new opportunities to build community prosperity by improving standards of health, the environment and quality of life.

MODERN SLAVERY & HUMAN TRAFFICKING

Haag-Streit UK has a zero-tolerance approach to modern slavery and human trafficking, and we are fully committed to preventing these in our organisation.

We firmly believe that by understanding and acknowledging the past and present activities of our customers and suppliers, we put ourselves in a greater position to actively avoid engaging with third parties whose actions are contrary to modern slavery and human rights legislation. We have assessed the Modern Slavery Act 2015 and ensured that our Modern Slavery Statement is aligned with it.

We periodically assess employee training needs, and ensure that Environmental, Social and Governance ("ESG") training has been provided to the relevant employees. We commit to ensuring that our whistleblowing reporting mechanisms are monitored for cases which may involve modern slavery and that these cases are dealt with efficiently.

We work with our suppliers to ensure the integration of our Supplier Code of Conduct is adhered to at each stage of our procurement process and support them with the development of modern slavery policies.
